

# NPDES & Clean Waterways Act Requirements Update

## What is NPDES?



- National Pollutant Discharge Elimination System
- Regulates discharges from MS4s, construction & industrial sites
- MS4 = Multiple Separate Storm Sewer System
- Statutorily required by F.S. 403.0885 & 62-621.300
- Requires the Town to
  - Reduce discharges to maximum extent practicable
  - Protect water quality
  - Satisfy water quality requirements of the Federal Clean Water Act (different than the State Clean Waterways Act, Senate Bill 712)

## Montverde's Permit



- Town is a Phase II MS4 permittee
- NPDES Permit is for five years
  - April 7, 2020 to April 6, 2025
  - Town is in Year 4, (a reporting year) April 7, 2023 to April 6, 2024
  - Report and new permit request will be due by October 6, 2024
- Permit has six minimum control measures
  - Public Education
  - Public Outreach
  - Illicit Discharge Detection & Elimination
  - Construction Site Stormwater Runoff Control
  - Post-construction Stormwater Management in New Development and Redevelopment
  - Pollution Prevention/Good Housekeeping for Municipal Operations
- Also requires activities to address TMDLs (Total Maximum Daily Loads)

## Other Reporting Requirements



- Office of Economic & Demographic Research
  - Section 403.9301 & 403.9302 F.S. (Chapter 2021-194)
  - Municipalities must develop a 20-year needs analysis every five years
  - Montverde submitted this via Lake County last July 31, 2022
- HB 1379 (2023)
  - Requires any municipality within a BMAP (Basin Mgmt Action Plan) to include in capital improvement of comp plan a list of projects to achieve load reductions
  - Must address treatment or upgrading of wastewater treatment plants & prioritize advanced waste treatment
  - Town's Comp Plan must be updated by July 1, 2024 and as needed thereafter
  - Lots of one acre or less prohibition of new conventional OSTDS (onsite sewage treatment and disposal systems AKA septic systems)
  - Sewage disposal facilities prohibited from discharging to any waterbody not meeting its TMDL

# Clean Waterways Act



- Senate Bill 712 (2020) Subparagraph 403.067(7)(a)9
- Promotes resilient wastewater infrastructure & utilities
- Includes water quality protections to be taken by municipalities to reduce impact of nutrient pollution sources on waterways by strengthening BMAP requirements
- Local governments (counties and municipalities) within a BMAP must develop a wastewater treatment plan and/or an OSTDS remediation plan if the Florida Department of Environmental Protection (FDEP) identifies domestic wastewater treatment facilities or OSTDS as contributors of at least 20% of point source or nonpoint source nutrient pollution or if the department determines remediation is necessary to achieve the TMDL
- Montverde is located within the Upper Ocklawaha River Basin BMAP and the Lake Apopka subbasin both with TMDLs for Total Phosphorus (TP)

# Clean Waterways Act



#### Developing strategies:

• Where allocations have not already been identified, they will be calculated as part of the BMAP updates due by July 1, 2025

#### Available funding:


- Springs Grants (may be poss. due to Lake Apopka's spring)
- Water Quality Improvement Grants including septic to sewer, WWTP improvements, OSTDS retrofits to nutrient-reducing OSTDS
- 319 Grants Federal grants for construction, education and monitoring. Projects could include water quality improvement/restoration, groundwater protection. Septic to sewer connections

#### Next steps:

- February 1, 2024 deadline for submitting draft OSTDS remediation and/or wastewater treatment plans to FDEP
- August 1, 2024 deadline to submit complete OSTDS and/or wastewater treatment plans to FDEP

# PUBLIC HEARINGS, ORDINANCE AND RESOLUTIONS

A Resolution of the Town Council of the Town of Montverde, Florida, granting a variance from Section 10-52(e) in Chapter 10 of the Montverde Land Development Code from the minimum lot width at building to allow a minimum lot width at building of 84' rather than the required 90' minimum lot width at building required in R1M zoning for the real property located at 17129 Lakeside Drive, Montverde, Florida, owned by Sarah Soltis and Justin Moorefield; providing for conditions; and providing for an effective date.

#### In order to authorize a variance, the committee must find:

- (1) That special conditions and circumstances exist which are peculiar to the land, structure or building involved and which are not applicable to other lands, structures or buildings in the same zoning district. Such onsite conditions may include, but are not limited to, topography, preservation of vegetation, access, vehicular and pedestrian safety and preservation of scenic views;
- (2) That the special conditions and circumstances do not result from the actions of the applicant;
- (3) That literal interpretation of the provisions would deprive the applicant of rights commonly enjoyed by other properties in the same zoning district under the terms of this chapter and would work unnecessary and undue hardship on the applicant;
- (4) That the variance granted is the minimum variance that will make possible the reasonable use of the land, building or structure;
- (5) That the grant of the variance will be in harmony with the general intent and purpose of this LDC and the comprehensive plan, will not be injurious to the neighborhood or otherwise detrimental to the public welfare; and
- (6) The granting of the variance will not be detrimental to the property or improvements in the area in which the property is located.

## Ordinance No. 2023-34




## Ordinance No. 2023-36
